

PUBLIC CIRCULAR NO. 2 OF 2016

REDUCTION IN DUTY ON SAWN TIMBER, PLYWOOD, INSULATED WIRE, CABLES AND OTHER INSULATED ELECTRICAL CONDUCTORS

To assist the people of Fiji rebuild their homes, business and factories, the Fiji Revenue & Customs Authority wish to advise that the Government has reduced duty rates on the following items as tabulated below.

The public at large including individuals and businesses can import directly and access this reduced duty rates.

- 2. All Insulated wire, cables and other insulated electrical conductors must comply with the FEA Wiring Regulations based on the AS/NZS Standards.
